1.7 **Definitions**

Site	has the meaning given to it in clause 1.1;
Terms	means these terms and conditions of use as updated from time to time under clause 11;
Unwanted Submission	has the meaning given to it in clause 5.1;
we	means Drakewood Capital Management Limited, company registration number 10774444, with VAT registration number 287 6730 55 and the registered office of which is at 16 Great Queen St, London WC2B 5AH, United Kingdom (and us or our shall have the same meaning). References to we, our and us in these Terms also includes our group companies from time to time; and
you	means the person accessing or using the Site or its Content (and your shall have the same meaning).

- 1.8 Your use of the Site means that you must also comply with our Acceptable use policy.

- 2.2 You agree that you are solely responsible for:
