<b>Content</b>	means any text, images, video, audio or other multimedia content, software or other information or material submitted to or on the Site;

<b>Unwanted Submission</b>	has the meaning given to it in clause 5.1;
<b>we</b>	means Drakewood Capital Management Limited, company registration number 10774444, with VAT registration number 287 6730 55 and the registered office of which is at 2 <sup>nd</sup> Floor, Amersham Court, 154 Station Road, Amersham, Buckinghamshire, HP6 5DW (and <b>us</b> or <b>our</b> shall have the same meaning). References to we, our and us in these Terms also includes our group companies from time to time; and
<b>you</b>	means the person accessing or using the Site or its Content (and <b>your</b> shall have the same meaning).
